

# **AUTHENTICATION OF WORKS BY CARLOS CRUZ-DIEZ**

The Cruz-Diez Foundation refers to the Cruz-Diez Documentation Center, where all blueprints and original plans are kept before making a decision. This enables the certificates committee to identify genuine pieces. A fee is payable to cover the cost of investigation, from which will come the possibility of obtaining a certificate. If a piece is deemed authentic, the certificates committee will then issue a certificate of authenticity.

## Each certificate is unique, and copies are not allowed.

If you own a Cruz-Diez artwork and would like to acquire a certificate, please complete our application form.

# **TERMS AND CONDITIONS**

To authenticate an artwork, the Authentication Board requires complete and accurate information about the piece:

- The fully completed Application Form must be sent along with all the required high-quality photographs of the artwork **at least 15 days before the Board's session**. If the application is not complete by this date, it will be examined in the next session.
- The applicant is committed to certifying that all the information submitted can be relied upon and that the information regarding the ownership and any other information concerning the work has not been withheld.
- The Cruz-Diez Foundation will not accept an application that has not been duly signed.

All the provided information is confidential. In case the Cruz-Diez Foundation would need to use the information for the Catalogue Raisonné of Carlos Cruz-Diez, an optional request for anonymity will be honored.

If the information and photographs the applicant submitted are not enough to authenticate the artwork, the Cruz-Diez Foundation will require a visual inspection of the artwork.

- The applicant agrees to leave the artwork at the disposal of the Cruz-Diez Foundation's experts in case they require a visual inspection.
- If this becomes necessary, the Foundation will communicate the instructions for the shipping. Transport and insurance will be at the applicant's own risks and expenses.
- The Cruz-Diez Foundation cannot be held responsible for any damage suffered by the work during its transport.

If the artwork is identified as an original Cruz-Diez, the Cruz-Diez Foundation will deliver a Certificate of Authenticity with the return receipt and signature of the applicant.
